Northwind Institute offers Faith-Based Non-Profit certificate programs in collaboration with WorldHope Corps under an articulation agreement for course content.

Northwind Theological Seminary offers transfer credit for the members of the National Christian Counselors Association who complete the required training program and receive licensure.

# NORTHWIND THEOLOGICAL SEMINARY DEGREE PROGRAMS

#### **BACHELOR OF MINISTRY DEGREE**

## Christian Counseling – 120 Credit Hours

Offered as a degree transfer options of the National Christian Counselors Association. Students transfer required courses from the NCCA Christian Counselor Training Program. [Phase I & II, 6 Advanced Courses, and a 500 question Bible exam]

#### **MASTER'S DEGREES**

## Master of Ministry – 60 Credit Hours

## **Theological Studies:**

Students complete 12 online courses featuring video-based micro-lectures or tutorial formats which provide a foundation of biblical, theological, and practical aspects of ministry. After completing the 12 required courses students design, implement, and submit a thesis describing the ministry project.

Prerequisite: Bachelor's degree

## **Specialized Ministry:**

Students complete 12 online courses using the Oxford pedagogy of reading, writing and conversations with a Faculty Tutor/Mentor to explore a specific specialization in ministry. Students request their area of specialized study during their application process. After completing the 12 arranged courses students design, implement, and submit a thesis describing the ministry project.

Prerequisite: Bachelor's degree & Ordination or Commission

## • Master in Christian Counseling – 40 Credit Hours

#### Master in Pastoral Counseling – 40 Credit Hours

Offered as a degree transfer options of the National Christian Counselors Association.

Students transfer required courses from the NCCA Christian Counselor Training Program.

[Bachelor degree, Phase I & II, 4 Advanced Courses, and a thesis presenting 25 APS case studies]

## • Master in Christian Life Coaching – 30 Credit hours

Offered as a degree transfer option of the Sarasota Academy of Christian Counselors Association. Students transfer required courses from the NCCA Christian Counselor Training Program.

[Master's degree, CT Certificate, CTLC certificate, and a thesis presenting 35 APS case studies]

#### **DOCTORATE DEGREES**

## • Doctor of Ministry – 30 Credit Hours

This program features the Oxford pedagogy of reading, writing and conversations with a Faculty Tutor/Mentor to explore a specific specialization in ministry. Students request their area of specialized study during their application process. After completing four arranged courses students design, implement, and submit a thesis describing the ministry project & presenting the supporting research for the project.

Prerequisite: Master's degree, Ordination or Commission, & three years of ministry experience

PhD in Clinical Christian Counseling – 60 Credit Hours
 PhD in Clinical Pastoral Counseling – 60 Credit Hours

Offered as a degree transfer option of the National Christian Counselors Association.

Students transfer required courses from the NCCA Christian Counselor Training Program.

[Master degree, Phase I & II, 8 Advanced Courses, and a thesis presenting 35 APS case studies]

NOTE: Pastoral Counseling degree requires ordination

#### **FINANCIAL POLICIES**

#### **TUITION:**

#### **SCHOLARSHIPS**

Northwind does provide a limited number of partial scholarships for degree programs. Students must submit a written request for scholarship assistance.

#### **PAYMENT POLICY**

Payment is due at the time of registration for any course.

#### **REFUND POLICY**

100% prior to accessing the online course or meeting with the course Faculty via videoconferencing.

0% after accessing the online course or meeting with the course Faculty via videoconferencing.

#### **MEDICAL LEAVE POLICY**

A doctor's note is required for any medical leave.

A doctor's note is required to return from any medical leave.

#### **LEAVE OF ABSENCE**

Students who do not plan to enroll for courses during any Trimester (September – December, January - April, or May – August) are required to complete an Application for Leave of Absence.

Students who do not return, who do not submit an Application for Leave of Absence, and students who do not return at the end of an approved Leave of Absence will be classified as Inactive.

Students classified as Inactive will need to submit a request for re-admission, pay any remaining account balance, and pay a processing fee.

## **ACADEMIC POLICIES**

#### **ACADEMIC ADVISING**

Student in degree programs are assigned an advisor to assist the student in interpreting the curriculum, selecting courses, and preparing for graduation. While advisors are available to help with course selection, students are solely and only responsible for successful progress and completion of their degree.

#### **CREDIT HOURS AND COURSE LOAD**

Students in certificate programs may be enrolled in up to three courses at one time.

Students in degree programs may not exceed 12 credit hours per trimester.

Students to exceed these course load limits are required to submit a written request describing the reasons for an exception to this policy.

#### **ATTENDANCE**

Students who miss scheduled classes or video-sessions for any reason assume personal responsibility for material covered during their absence. Excessive absence from scheduled classes or video-sessions, with or without an excuse, may necessitate the assignment of additional work, and will be considered in the evaluation of the final grade for a course.

#### **ACADEMIC PROGRESS**

All students are required to make academic progress in their certificate or degree programs.

Students in certificate programs must complete course in 90 days.

Students in degree programs must be currently enrolled in at least one 3-credit course and complete all courses within 90 days.

Courses not completed in 90 days will receive a grade of 'W'.

Students receiving a 'W' will be required to re-enroll in the course and pay the required tuition.

## **EXTENSIONS**

Students seeking an extension must make a written request stating the reason for the extension and the duration of the extension.

Courses not completed by the end of the extension will receive a grade of 'W'. Students receiving a 'W' will be required to re-enroll in the course and pay the required tuition.

#### **Academic Honors:**

The Seminary awards academic honors for scholastic performance in degree programs. These honors are printed on the diplomas and transcripts of the recipients.

## **ACADEMIC PROBATION**

Students in the Seminary degree programs may be placed on academic probation at the time of admission to the Seminary or following any semester in which their cumulative grade point average falls below a "C" (2.0).

#### **ACADEMIC SUSPENSION**

Students in the degree programs who continue for two consecutive semesters on academic probation will be suspended from the program for at least one semester. Given extraordinary circumstances and definite signs of progress Northwind has the discretion to permit a student to continue academic probation more than the allowed number of semesters.

## **ACADEMIC HONESTY**

Academic honesty and integrity are expected of all students. Plagiarism or the copying and submission of work that is not the students' own will not be tolerated. Dependence on the works of others must be adequately and appropriately acknowledged. Academic dishonesty is a grave offense that may result in dismissal from the Seminary.

## **SUBSTITUTION FOR REQUIRED COURSES**

In certain circumstances, students may be granted permission to substitute courses. A request for such a substitution is to be made in writing to the Registrar, clearly stating the benefits to be derived from the substitution.

## Textbooks:

Textbooks are not included in the tuition fees for courses.

Textbooks are available from Amazon.com in both print and kindle versions.

## **REQUIREMENTS FOR GRADUATION**

The basic requirements for receiving a Certificate of Completion for certificate programs are:

- 1. Satisfactory completion of the required course(s)
- 2. Satisfaction of all financial obligations to Northwind Institute, LLC
- 3. Exemplary Christian conduct
- 4. An Exit Interview

The basic requirements receiving a Diploma for degree programs are:

- 1. Satisfactory completion of the required credit hours of course work over a minimum of three academic years and a maximum of ten years, fulfillment of the required distribution of the curriculum, with a grade point average of at least C+ (2.33)
- 2. A minimum of 25% of course work completed at Northwind
- 3. Satisfaction of all financial obligations to the Northwind Theological Seminary
- 4. Exemplary Christian conduct
- 5. An Exit Interview

Addition requirements may be part of specific programs.

Students will be notified of any additional requirements in a timely manner.

# **Education Rights and Privacy Act, 1974 (Buckley Amendment)**

In accordance with the Family Education Rights and Privacy Act (Section 513 P.L. 93-380, Education Amendments of 1974, which amends the General Education Provisions Act, Sec. 438), the students of the Seminary are hereby informed of their right of access to their official records, as described in the Act. These rights include:

- The right to inspect and review the student's education records within 45 days of the day the Seminary receives a request for access. a. A student should submit to the Registrar, or other appropriate official, a written request that identifies the record(s) the student wishes to inspect. The Seminary official will arrange for access and notify the student of the time and place where the records may be inspected.
- 2. The right to request the amendment of the student's education records that the student believes are inaccurate, misleading, or otherwise in violation of the student's privacy rights under FERPA. A student who wishes to ask the Seminary to amend a record should write the Seminary official responsible for the record, clearly identify the part of the record the student wants changed and specify why it should be changed. If the Seminary decides not to amend the record as requested, the Seminary will notify the student in writing of the decision and the student's right to a hearing regarding the request for amendment. Additional information regarding the hearing procedures will be provided to the student when notified of the right to a hearing.
- 3. The right to provide written consent before the Seminary discloses personally identifiable information from the student's education records, except to the extent that FERPA authorizes disclosure without consent. The Seminary discloses education records without a student's prior written consent under the FERPA exception for disclosure to school officials with legitimate educational interests. A school official is a person employed by the Seminary in an administrative, supervisory, academic or research, or support staff position (including law enforcement unit personnel and health staff); a person or company with whom the Seminary has contracted as its agent to provide a service instead of using Seminary employees or officials (such as an attorney, auditor, or collection agent); a person serving on the Board of Trustees; or a student serving on an official committee, such as a disciplinary or grievance committee, or assisting another school official in performing his or her tasks. A school official has a legitimate educational interest if the official needs to review an education record in order to fulfill his or her professional responsibilities for the Seminary.
- 4. The right to file a complaint with the U.S. Department of Education concerning alleged failures by the Seminary to comply with the requirements of FERPA. a. The name and address of the Office that administers FERPA is:

#### **Notification of Disclosure of Directory Information**

At its discretion, Northwind Theological Seminary may provide "directory information" in accordance with the provisions of FERPA.

Directory information is defined as that information which would not generally be considered harmful or an invasion of privacy if disclosed. Designated directory information at Northwind Theological Seminary includes the following: student's name, local address and permanent home address, email address, photograph, telephone, date and place of birth, degree program and enrollment status (part-time, full-time, dates of attendance), cross-listed class rosters, institutions of higher education previously attended including dates attended and degrees awarded; and prizes, honors, special recognitions and degree(s) awarded by the Seminary.

Students may block the public disclosure of "directory information" (all or in part) by completing requesting a FERPA block, in writing, from the Registrar.

Requests will be honored by the Seminary until revoked, in writing, by the student.

Please consider very carefully the consequences of a decision to block the disclosure of directory information. Placing a block on disclosure of all or part of the directory information will prohibit the Seminary from releasing the blocked directory information; and thus, any future requests for such information from non-institutional persons or organizations will be refused.

Northwind Theological Seminary will honor student requests to block disclosure of student directory information but cannot assume responsibility for contacting students for subsequent permission to release directory information. Regardless of the effect upon the student, Northwind Theological Seminary assumes no liability as a result of honoring student instructions to block disclosure of directory information.
